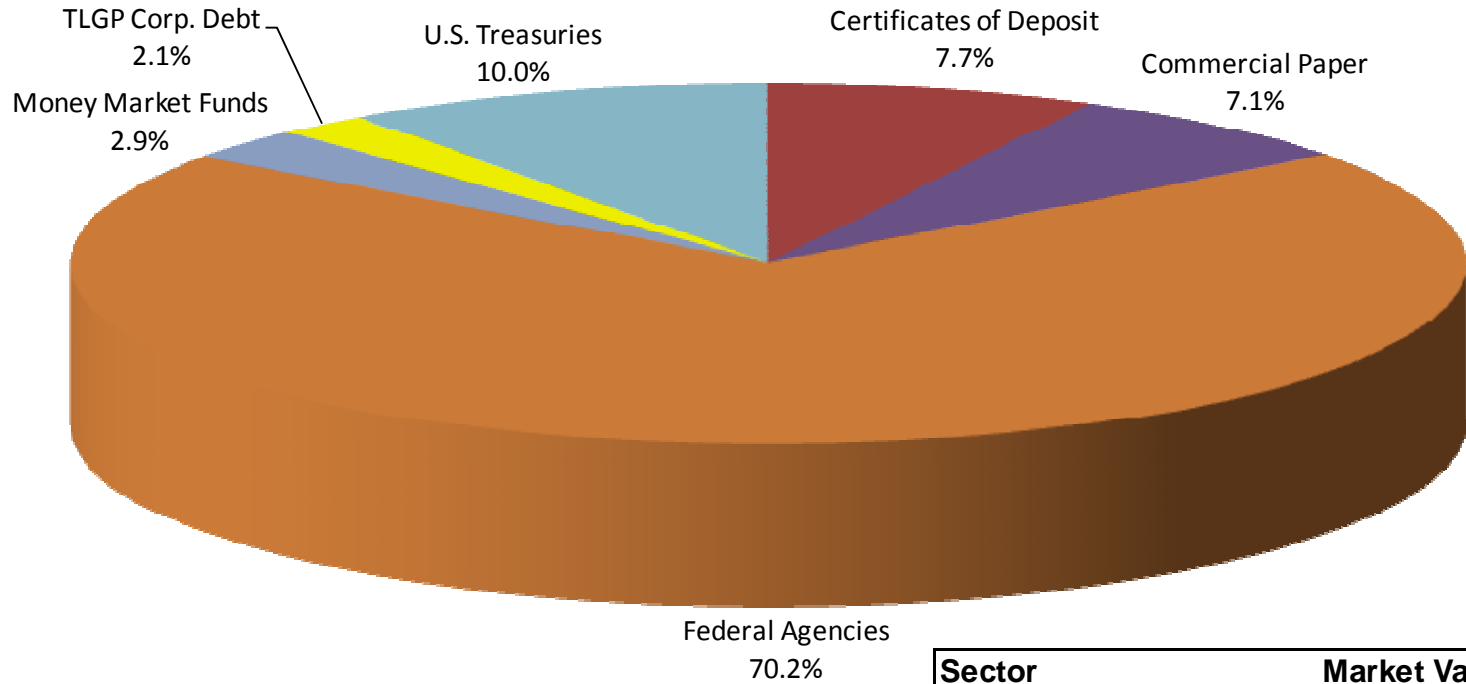

San Bernardino County Pool Credit Quality Distribution (as of 12/31/09)

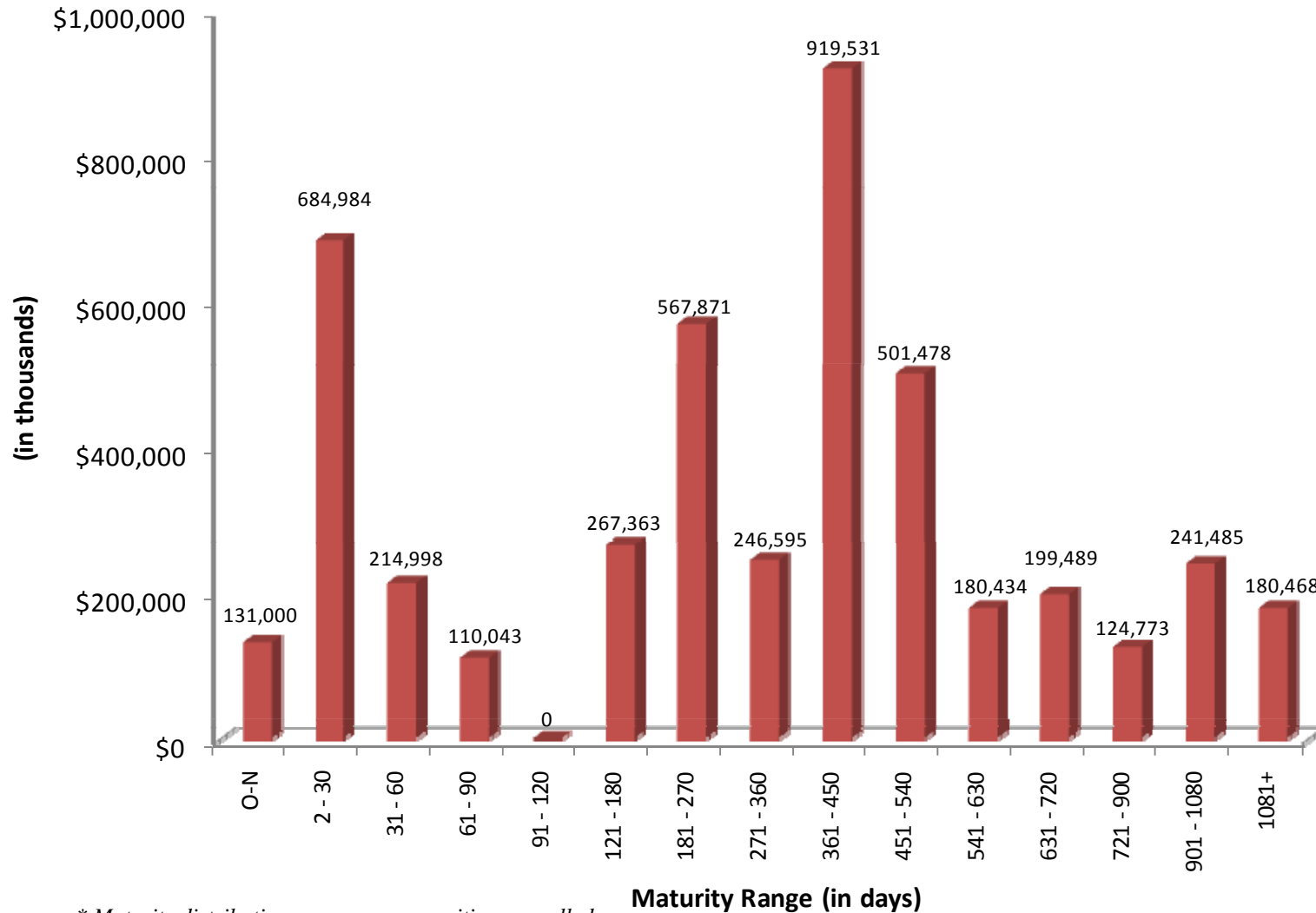
