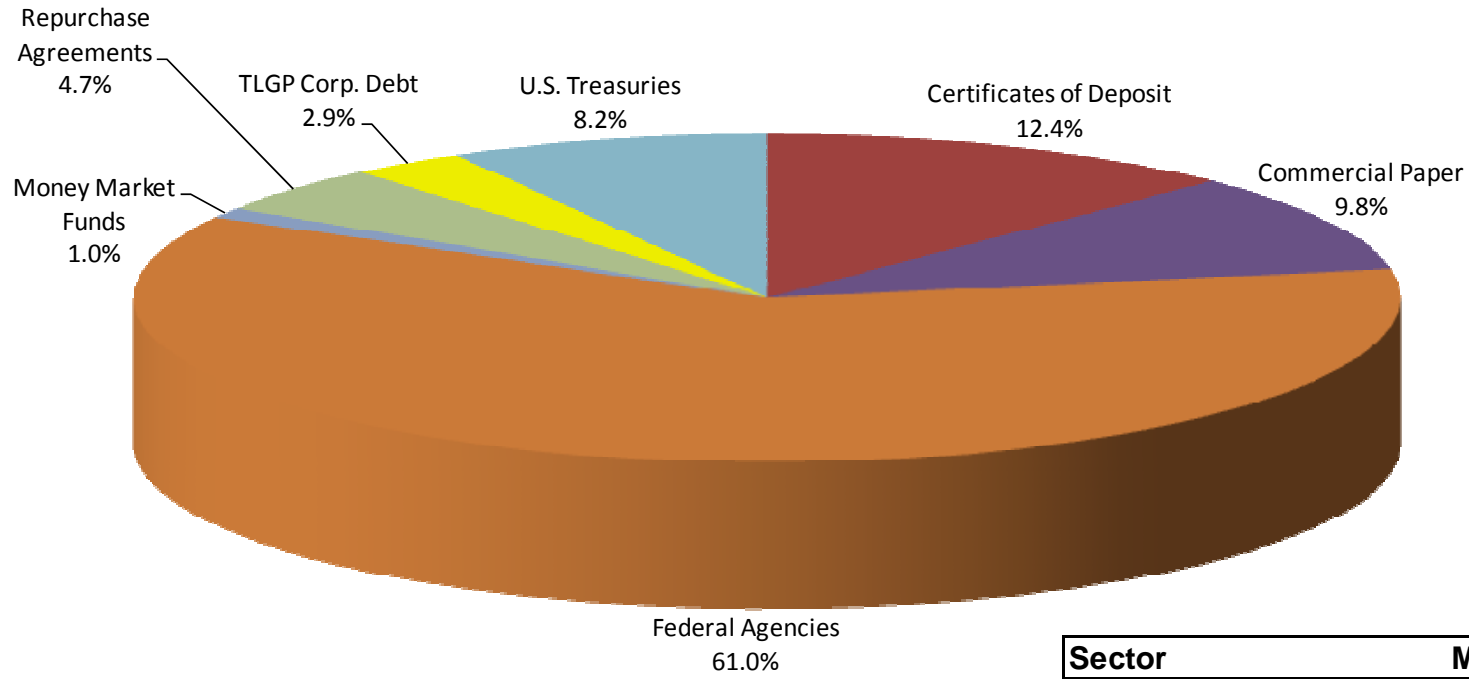

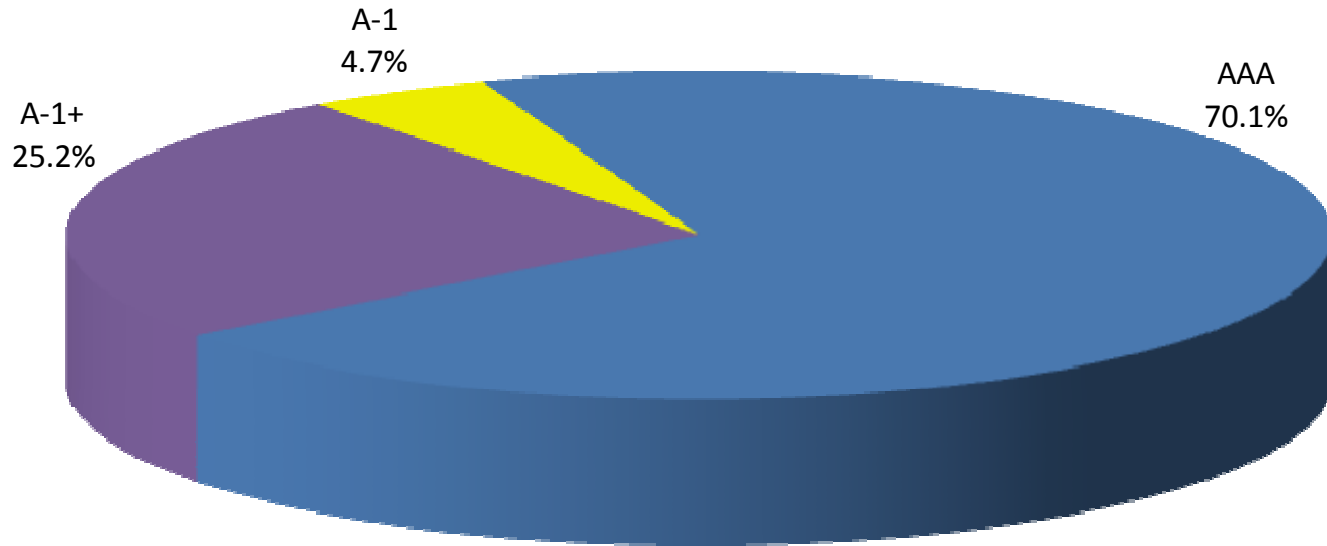
Sector Distribution (as of 11/30/10)

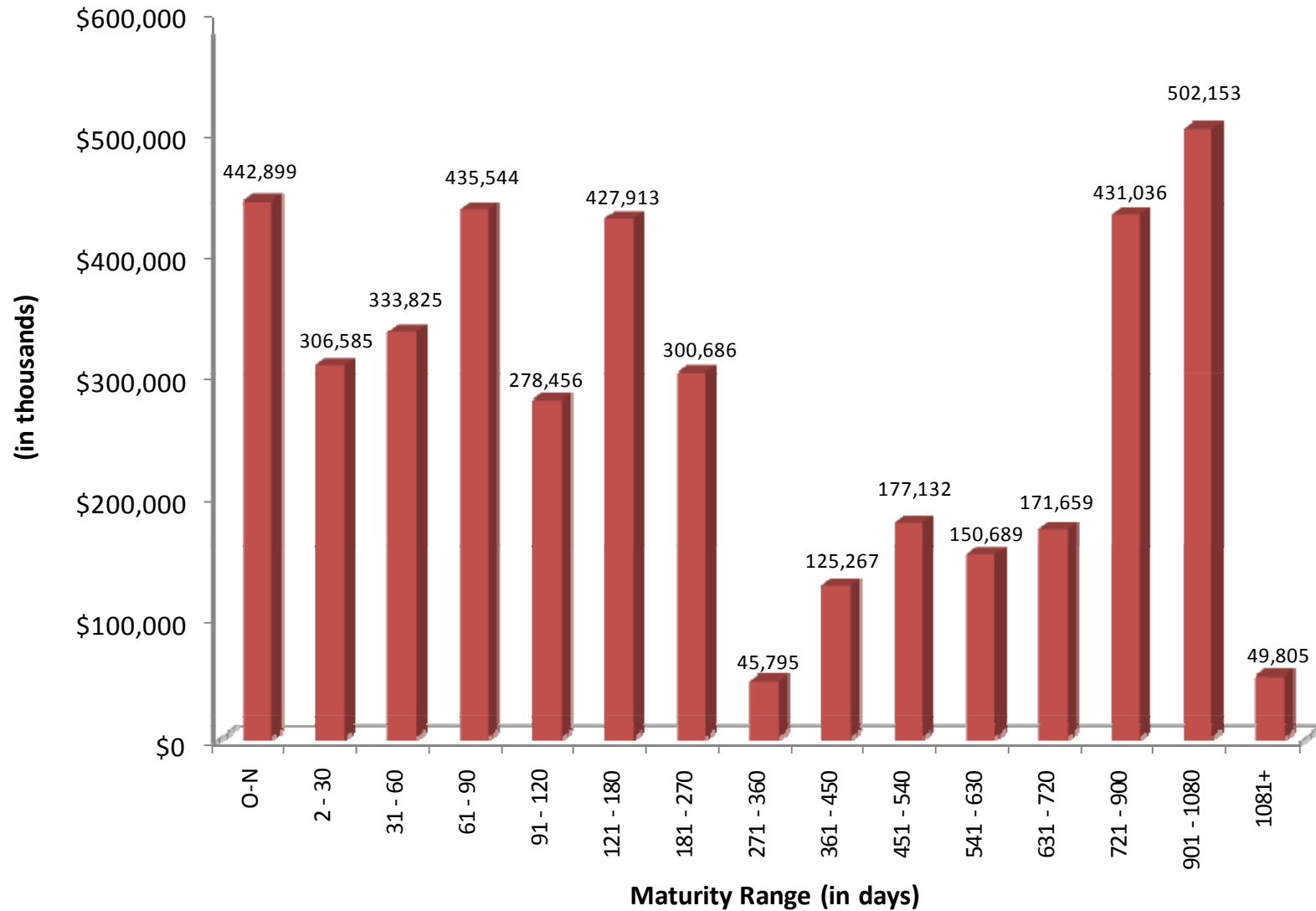
San Bernardino County Pool Credit Quality Distribution (as of 11/30/10)
