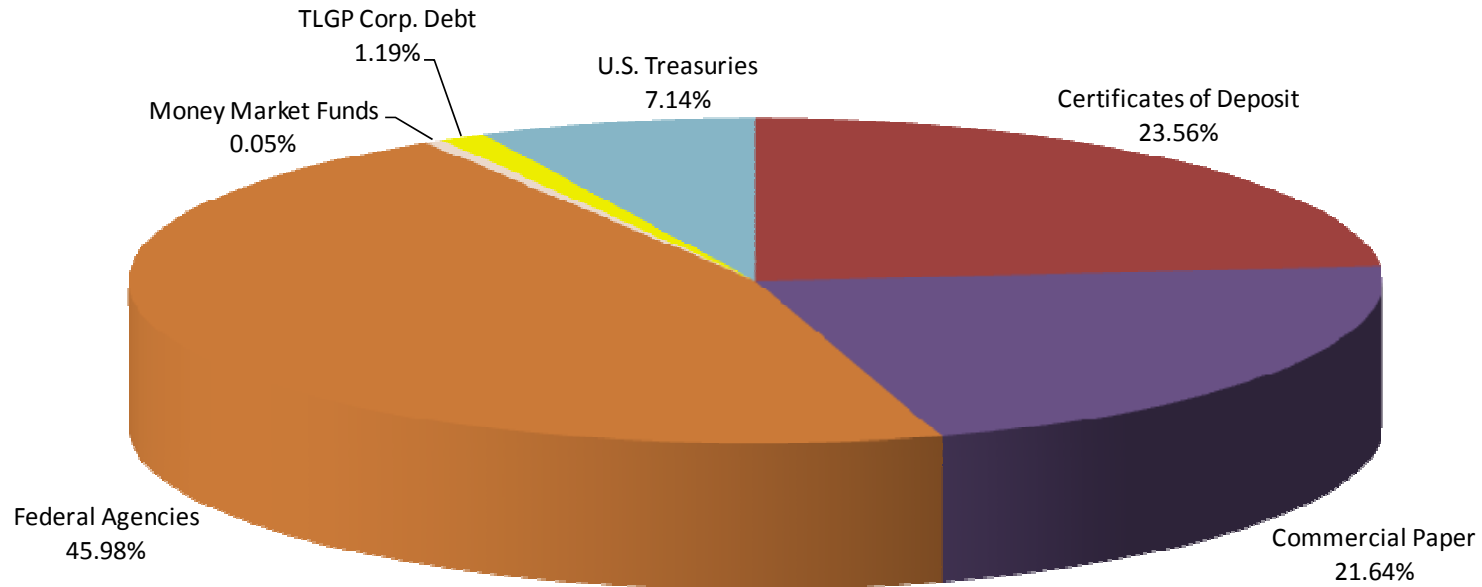

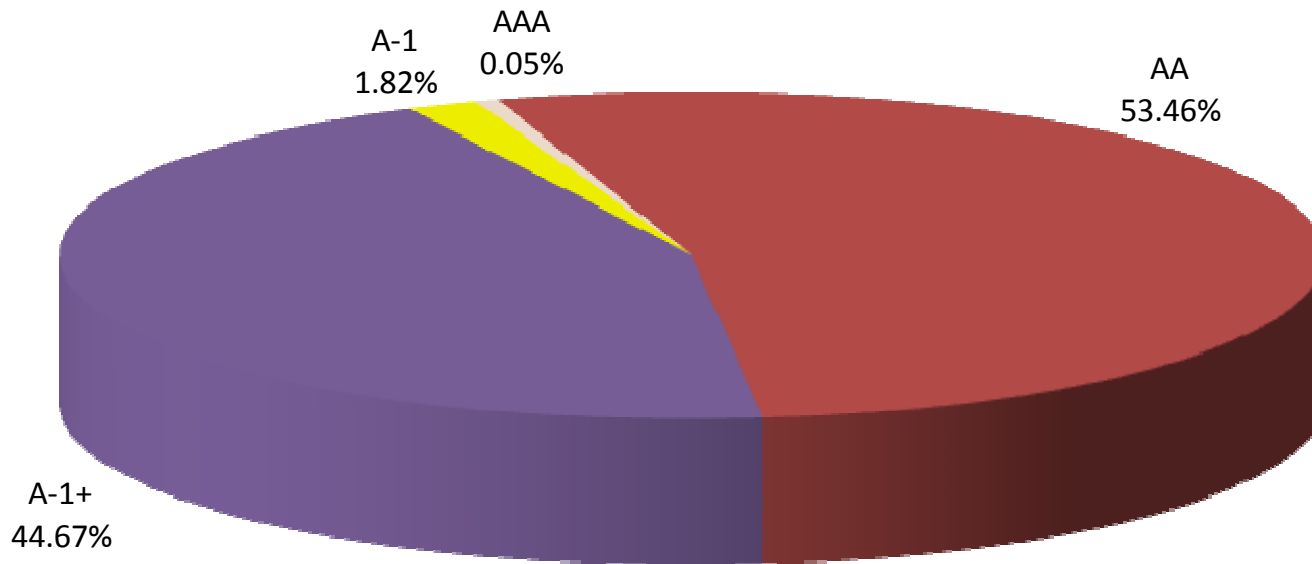
Sector Distribution (as of 8/31/11)

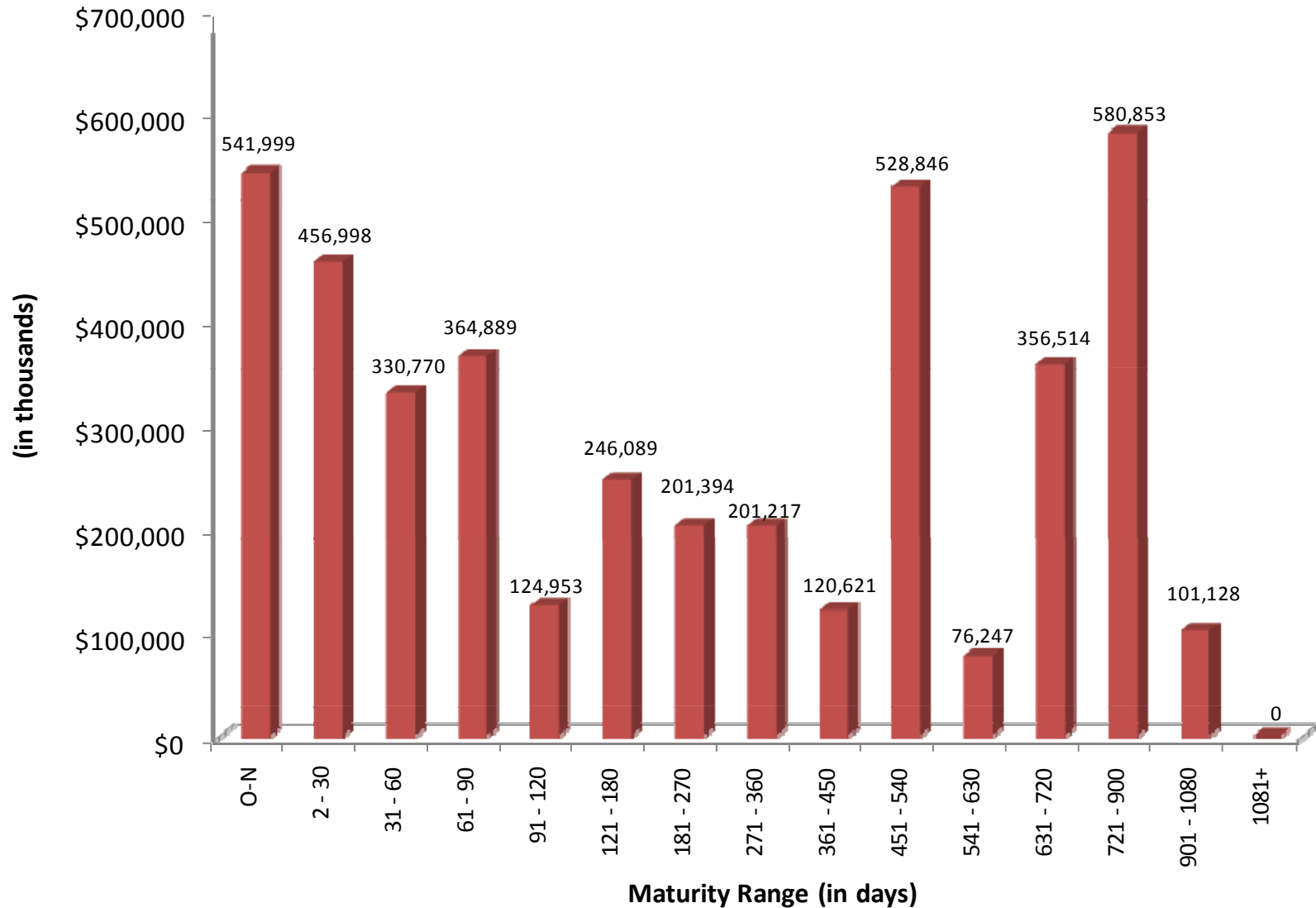
San Bernardino County Pool Credit Quality Distribution (as of 8/31/11)
