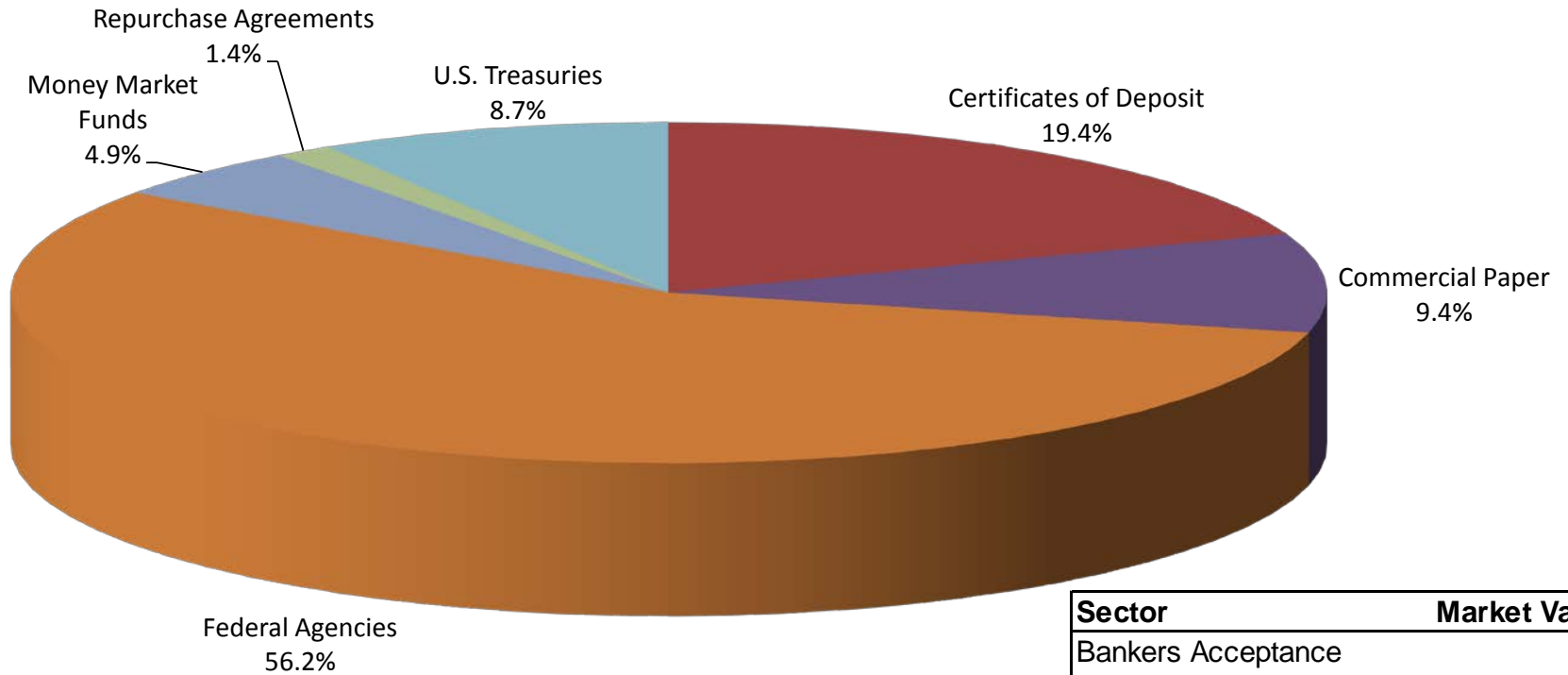

# San Bernardino County Pool Sector Distribution (as of 6/30/2012)

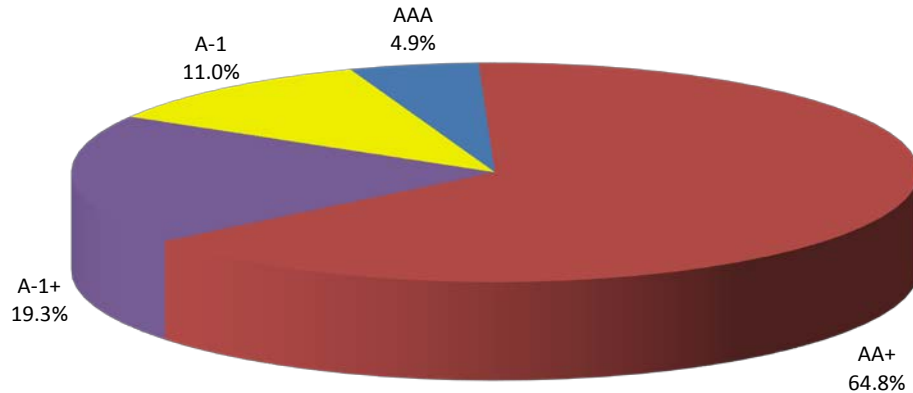

# San Bernardino County Pool Credit Quality Distribution (as of 6/30/2012)

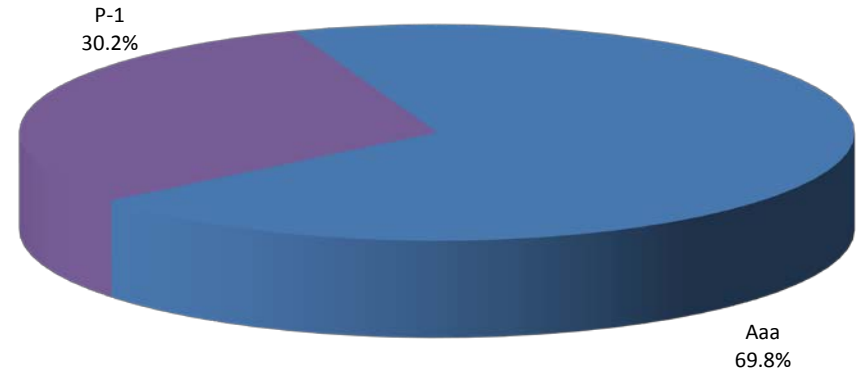

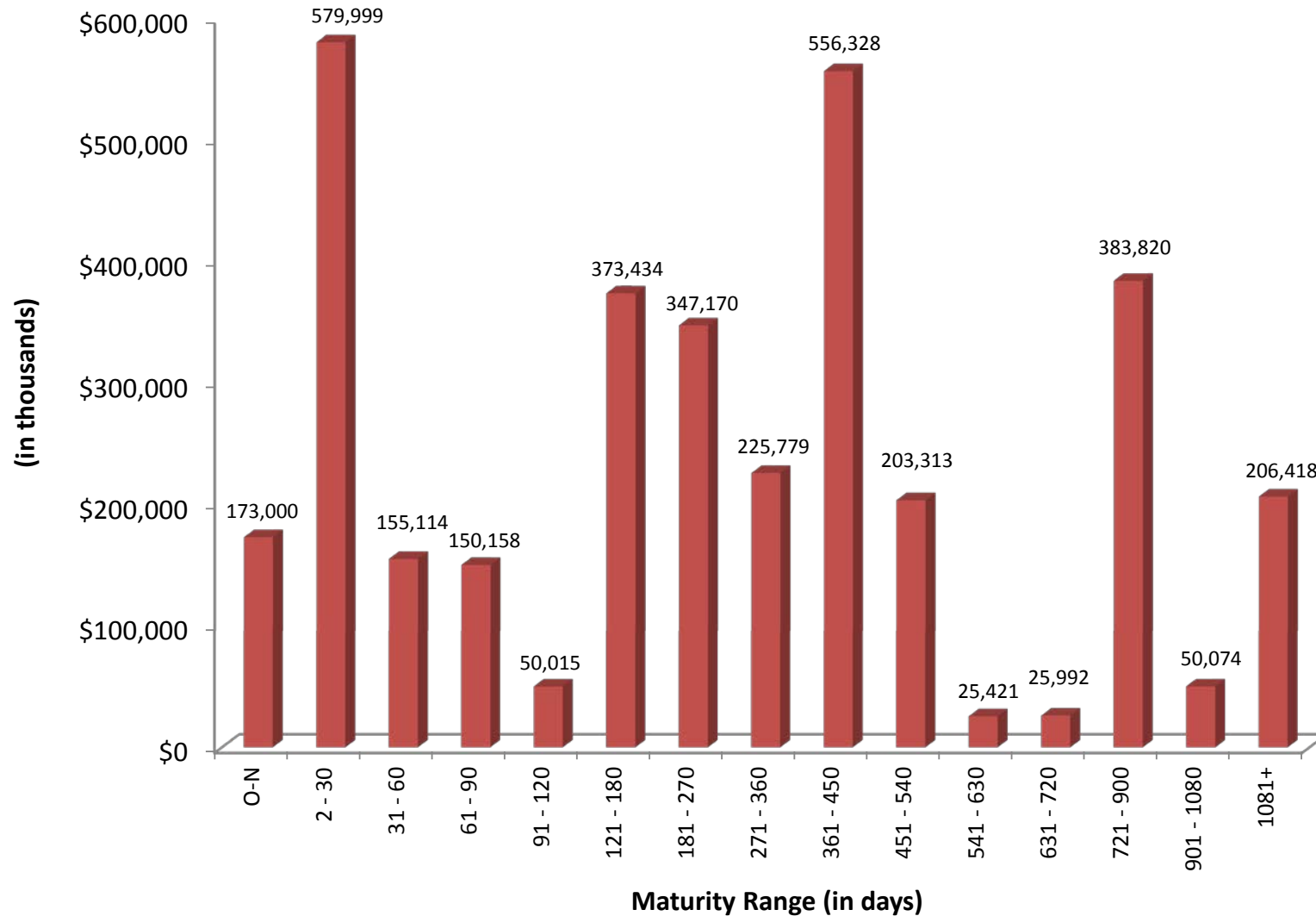
